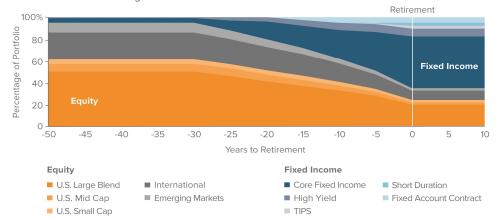

Fund highlights
